

Dear Prime Minister Madbouly,

BREECH OF AGREEMENT BY SUPREME COUNCIL ANTIQUITIES & SCAN PYRAMIDS

In December 2021 the director of the Science Office – Supreme Council of Antiquities agreed to receive my research, free of charge, on the basis that I would provide my expertise in directing the Scan Pyramids team to examine the Southern Passage of the Subterranean Chamber; Khufu's Pyramid.

Following a series of presentations and meetings over four years with the Director El Seaidy, the Minister, the Secretary General Waziri and the Secretary General Mohie of the Giza Site, the complete digital and hard copies of my research were delivered personally to the Head Office of the Supreme Council in Cairo; they were received at the request of your people and the blessing of Secretary General Ashraf Mohie when he said "Tell Dr Waziri that it's all good with me".



From the time we made these agreements (which are recorded in Zoom Video Records), not one scan has taken place despite my travelling to Egypt, at my expense, several times. No satisfactory explanation has been proffered – except 'we are afraid that Israel will come and take our land'. Scientific discovery should not be obstructed by fear!

None of this is for my benefit, in fact, I have only asked for one thing, and that is anonymity upon the confirmation of my discovery. That the Ark of the Covenant is hidden in a twin cave adjacent to the subterranean chamber, within which will be found the burial Tomb of Khufu also.

IMPORTANT IMPLICTIONS FOR TOURISM & CURRENCY CRISIS

My research and site work have demonstrated clearly and conclusively that this discovery is to be found behind one stone block with seals the Southern Passage. Why will your scientists not act for the economic benefit of Egypt?

Such a discovery presented to the new Grand Egyptian Museum would bring millions of new tourists to Egypt on religious pilgrimage by Muslim, Christian and Jew. Half of the world's population are mandated by religion to visit the Ark of the Covenant and the Temple where it is found. This means million of new tourists bringing billions of US dollars!

I trust that you will immediately see the merits of what I am saying and correct the mistakes made by your staff.

A breech of this magnitude could have embarrassing consequences for the people involved, if I were forced to make my records public or indeed refer them to an international law tribunal. For myself I ask nothing -I seek only the prosperity of the Egyptian people in their time of crisis.

On the 23rd of April 2024, I was granted access to the subterranean chamber where my own private sonic scans identified manmade structures and artefacts beyond the stone block in the hidden twin chamber. (See image above).

I leave this matter in your capable hands. It is essential that you proceed with urgency.
